TERMS AND CONDITIONS

1. The sealed bid shall be received by this office at ICAR-ATARI, Bhumi Vihar Complex, Salt Lake, Kolkata 700097 up to 3.00 PM on 09.06.2022. Any bid received after the prescribed deadline shall not be considered.
2. The rates quoted by the bidders for purchase of old condemned vehicle will be all inclusive and on "As is where is basis". Any statutory or other charges shall be borne by the bidder. The successful bidder will take possession of the vehicle on a date and time specified by the office and will arrange for transportation of the same on that day at his expenses.
3. The vehicle will be disposed off on the basis of highest rate. However, this office reserves the right to withdraw the vehicle from the bidding process in case the quoted price received is less than the reasonable market price.
4. The successful bidder must adhere to the time limit. Failure to deposit the requisite sum before the stipulated date/time, will entail the forfeiture of the contract as well as Earnest Money Deposit. After delivery of the vehicle, this office will not be responsible for any damage to the vehicle or person.

This office reserves the right to annul the bidding process at any time prior to award of contract including rejection of any or all bids after the same have been received, without thereby incurring any liability to the affected bidder/s or any obligation to inform the affected bidders on the ground of this office's action.
